**RULES FOR THE GRANT OF MARGIN MONEY ASSISTANCE BY WAY OF
SHARE CAPITAL CONTRIBUTION TO THE KERALA STATE CO-OPERATIVE
CONSUMER FEDERATION/DISTRICT WHOLE SALE STORES/
PRIMARY CO-OPERATIVE SOCIETIES FOR THE IMPLEMENTATION
OF RURAL CONSUMER SCHEME OF N.C.D.C.**

(Issued in G.O. (MS) 206/97/AD Date: 11-07-1997)

- 1) These rules may be called the Rules for the grant of share capital contribution to the Kerala State Co-Operative Consumer Federation/District Wholesale store/Primary Co-operative Societies for the implementation of the Rural Consumer Scheme of NCDC.
- 2) Financial assistance by way of contribution to the Share Capital of the Kerala State Co-operative Consumer Federation/District Wholesale Stores/Primary Co-Operative societies may be given by the State Government to the State Co-Operative Consumer Federation/District Wholesale Stores/Primary Co-operative societies which have implemented the Rural Consumer Scheme of NCDC.
- 3) The State federation of Consumer Co-Operative Stores eligible for Share Capital Contribution should satisfy the following conditions.
- The store should adopt the bye-laws prescribed by the Register of Co-operative Societies for the purpose.
 - The Federation shall agree to take the services of a Government Officer to work as Managing Director of the Federation if the Registrar so direct.
- 4) The Consumer Federation/District Wholesale Stores/Primary societies obtaining assistance shall amend its bye-laws in such manner, adopt such business practices and maintain such records and books of accounts as the Registrar maytime to time prescribe.
- 5) The application for financial assistance shall be forward to the Registrar of Co-operative Societies through the Joint Registrar concerned which shall recommended to NCDC through State Government. It shall be supported by ~~Committee of Federation/Wholesale Stores/Primary societies~~ permits such application and agreeing to abide by

these Rules and shall be in accordance with the Scheme prescribed by NCDC.

6) The assistance sanctioned by NCDC shall be released to the Federation/ Wholesale/Primary Societies by the Registrar of Co-Operative Societies/ Government in accordance with G.O.Rt.1114/85/AD Dated 30.4.1985 and shall be withdrawn only after getting the prior permission of Registrar of Co-operative Societies.

7) The Federation/District Wholesale/primary societies shall forward to the Registrar of Co-operative Societies printed a share Certificate in favour of the Governor of Kerala within one month of the encashment of the bill.

8) The Federation/District Wholesale Store/Primary Co-operative society obtaining share capital assistance should not refund any share of the society members unless the ratio of the shares contributed by them to the Share contributed by Government exceeds 1.1 and without prior sanction from the Joint Registrar concerned. The balance of the total share capital (including Government Share contribution) remaining after such refund shall not be less than the share contribution made by the Government.

9) The Government contribution towards the share capital of the Federation/District Wholesale Stores/ Primary Societies under the se rules will be for a period of 10 years repayable in 8 annual equal installments, the 1st installments commencing from the 3rd anniversary of the grand of the contribution.

10) No withstanding anything contained in these rules or in the bye-laws of the Federation/District Wholesale Stores/Primary Co-operative Societies, it shall be open to the Government to withdraw at any time without stating

liable to refund Government the value of the share so withdrawn.

11) The dividend accruing on the Share Capital contribution by the Government shall be remitted to the Treasury within one month after the declaration of the

dividend by the General body of the Federation/District Wholesale Stores' Primary Co-operative Store.

12) The Federation/District Wholesale Stores/Primary Co-operative Society receiving assistance shall executed an agreement Form 'A' appended to these rules.

13) The powers and function of registrar of Co-operative Societies mentioned in these rules shall be exercisable also by other Officers of the Co-operative Department having delegation of powers.

14) The Government may be order and for reasons to be stated exempt the Federation/District Wholesale Stores/Primary Co-operative Society from any Of the provisions contained in these rules.

15) If the Stores/Society default in the payment of any installment an amount equal to 2 ½ of such defaulted amount shall be charged from the date of such default and the Store/Society shall be liable to remit this amount also along with the installment amounts with the time limit allowed by Registrar of Co-operative Societies. If any Store/Society fails to comply with these directions of Registrar of Co-operative Societies, the entire amount of assistance shall be recoverable in lump.



AND WHEREAS THE NCDC have agreed to the participation in the share capital of the Society in Order No..... Dated and Government (Registrar of Co-operative Societies) Order No. Dtd..... (herein after referred to as "the said order which from part of this deed as if incorporated herein) subject to the terms and conditions contained therein and in the said rules and those herein after appearing.

NOW THESE PRESENTS WITNESSESS AS FOLLOWS

1) The amount of Rs. (Rupees) only) advanced to the Society (the receipt of which the.....do hereby admit and acknowledge) shall be utilized only for the contribution to the share capital of the Koliyakodu Consumer Co-operative Society and for no other purpose.

- 2) The Society shall abide by all the terms and conditions contained in the Said Rules, a copy of which is herewith appended which shall form part of this agreement.
- 3) In case the Society commits breach of all or any of the terms and conditions herein contained or those contained in the Said Rules or in the Said Order the entire amount advanced shall become payable in lump at once the Society shall pay the same to the government at once.
- 4) The Society hereby agree to make suitable provisions in the byelaws of the Society in accordance with terms and conditions in the Said rules.
- 5) All the sums found due to the Government under or by virtue of this agreement shall be recoverable from the Society and its assets movable and immovable under the provisions of the Revenue Recovery Act for the time being in force as though such are arrears of land revenue or in such other manner as Government may deem fit.

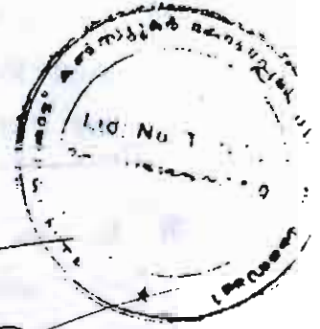
